We agree with the Reviewer 1's comment. However, abdominal X-ray is often first step for diagnosing abdominal illnesses in the clinical setting. Furthermore, in this case, the abdominal X-ray showed highly suggestive, characteristic findings of colonic ileus due to fecal impaction, which should be useful and helpful for clinicians.
