Reviewers' comments:

Reviewer #3: Dear authors,

Thank you for submitting a revised draft to JCTR and for following up with a point-by-point response to the reviewers' comments.

Inasmuch as the reviewer comments were very minor, I have appraised the manuscript myself to ensure that there were no evident fundamental issues that had remained.

Please address the following issues:

The language level needs to be raised to academic English. It is not just the incidental spelling/grammar errors, but also syntax mishaps and conceptual language errors. For example:

- There were 758 male participants, 671 of all were girls -> the reference to the girls is off in terms of phrasing. Moreover, why do you refer to the male population as "male" and to the female population as "girls"? This is a clear example of the conceptual language misuse I was referring to.
- "Preventive or interceptive orthodontics that is entitled early treatment according..." is incorrectly phrased (syntax error with entitled, which I think should be classified or considered).
- "The prevalence is reported 93% in Latino adolescents" -> syntax error; reported should be removed or rephrased to "The prevalence of malocclusion in Latino adolescents in reportedly 93%."
- ...problems (Angle's... -> parentheses not closed
- ethnicity and other demographic variables are not really considered factors that affect malocclusion and therefore should not be phrased as such. I think it would be better to state that your study determined whether these variable were predictive of malocclusion (such as a risk ratio).
- Another example is "...included all children aged 6 to 12 years old in elementary schools (grades 1 to 6). In the present study, students in the fourth and fifth grades of elementary

schools were selected as the study population." In the latter sentence, you do not need to indicate that the 4th to 6th grades refer to elementary school since you had already established this parameter in the preceding sentence.

Please go through the entire text and correct all remaining errors, using the points above as baseline examples of the types of mistakes you should be looking for. My list is non-exhaustive and the fundamental nature of the requested corrections should be applied broadly to the whole text.
